

COURSE DESCRIPTION

• This short course includes the decorative and functional planning of domestic environment. It covers both practical and aesthetic aspects of decorating and projects are orientated towards a portfolio of a professional standard.

STUDY MATERIAL

- Students enrolled for the decorating short course need to purchase equipment. The equipment list will be discussed on the 1st session so that students can see what is required. The cost of the kit ranges from R650.00 to R1000.00, depending on the student's needs.

ASSESSMENT

• Students are required to complete a Portfolio of Evidence that will include two Interior Decor briefs. The portfolio may be used to apply for enrolment into the full-time Diploma in Interior Design or Higher Certificate in Interior Decorating programmes offered by BHC. The Certificate of Competency is contingent on the successful evaluation of a Portfolio of Evidence.

Entrance requirements: Basic computer literacy

 The purpose of this course is to provide the student with the skills and knowledge required to use the SketchUp package to quickly and efficiently generate 2D geometry and 3D models for interior design proposals.

COURSE DESCRIPTION

 The purpose of this course is to provide the student with the skills and knowledge required to use the Revit Architecture package to quickly and efficiently generate 2D documentation and 3D models for architectural and interior projects.

STUDY MATERIAL

Students will be supplied with a reference manual

ASSESSMENT AND ACCREDITATION

• BHC Certificate of Competency, which will be awarded on achieving the Autodesk Certificates of Completion for the 5 modules covered.
